

## What is a CPESC?

A CPESC is a recognized specialist in soil erosion and sediment control. The certification program, sponsored by the Soil and Water Conservation Society and the International Erosion Control Association, provides the public with evidence of professional qualifications. This designation is given to specialists who have met established standards of expertise, experience and knowledge.

---

A CPESC must demonstrate through education, experience and examination, knowledge of effective and economical methods of minimizing soil erosion and sediment transport due to land-disturbing activities.

The CPESC program is designed for individuals involved in the following E&SC activities:

- ◆ Development and review of permits.
- ◆ Design and review of E&SC and drainage plans
- ◆ Installation and inspection of E&SC practices
- ◆ Related activities (such as, assisting regulators, authoring handbooks, and educating the public).
